- 3 The undersigned purchaser agrees in the event the account becomes delinquent and is turned over for collections, to pay all costs, including all reasonable attorney fees, plus court costs, repossession fees and/or collection agency fees, together with interest thereon at the maximum amount allowed by law.
- 4 The undersigned agrees to notify Allied Oil & Tire Company by certified mail of any change in ownership of the customer and further agrees to be liable for all purchases should the undersigned fail to comply with said notification. In the event that this guarantee is executed by more than one person, then, in such event the liabilities and obligations of the undersigned hereunder shall be joint and several of the relative words herein shall be as written in plural.
- 5 The undersigned purchaser understands and agrees that the granting of any credit to purchaser hereunder and/or the amount of the term of such credit is the sole exclusive decision of Allied Oil & Tire Company.
- 6 The undersigned purchaser hereby certifies that all information contained herein is true and correct.
- 7 The undersigned purchaser understands that for credit lines in excess of \$1,000.00 the execution of a personal guarantee may be required.
- 8 The undersigned (Customer) agrees that credit inquiries may be made at any time in connection with the credit hereby applied for, and consents to the disclosure of such information by any person with whom the undersigned may have financial relations. All payments due at any time from the Customer of Allied Oil & Tire Company that are not paid when due shall be delinquent and shall, at the option of Allied Oil & Tire Company at once become due and collectible, with any accrued interest regardless of any forbearance. Any delinquent account shall bear interest from the due date at a rate of interest equal to 18% per annum. In the event it becomes necessary for Allied Oil & Tire Company to collect any delinquent account of Customer, Customer agrees to severally waive, as to the amount of any delinquent account, all exemptions of personal property under the Constitution and laws of the State of Nebraska, or any other State, and agrees to pay all costs of collection, including court costs and reasonable attorney fees. This Agreement shall be governed by the laws of the State of Nebraska. The Courts of Douglas County, Nebraska shall have original jurisdiction to hear and determine any claims or disputes pertaining to this Agreement.
- 9 Allied Oil & Tire Company shall assess a reasonable charge in the amount of four percent (4.0%) to offset the additional administrative costs incurred by Allied Oil & Tire Company when a Customer pays all or a portion of the credit account balance by credit card. Such charges shall be added to the Customer's convenience credit card balance prior to completing the credit card payment transaction.
