**Methods and material for containment and cleaning up:**

Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Dike far ahead of larger spill for later recovery and disposal.

**Environmental Precautions:**

Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so.

**7. Handling and storage**

**Precautions for safe handling:**

Contains amines. Do not add sodium nitrite or other nitrosating agents which may form cancer causing nitrosamines. Do not get in eyes. Wash hands thoroughly after handling. Use caution when adding this material to water. Add material slowly when mixing with water. Do not add water to the material; instead, add the material to the water. Avoid contact with eyes, skin, and clothing.

**Conditions for safe storage, including any incompatibilities:**

Store in original tightly closed container. Avoid contact with oxidizing agents. Store away from incompatible materials.

**Protective Measures:**
