Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Dike far ahead of larger spill for later recovery and disposal.

Environmental Precautions:

Avoid release to the environment. Prevent further leakage or spillage if safe to do so. Do not contaminate water sources or sewer.

7. Handling and storage

Precautions for safe handling:

End-users should follow industry best practices for handling and using this product.

Guidance may be found using the current version of ASTM Standard E1497-05: Standard Practice for Selection and Safe Use of Water-Miscible and Straight Oil Metal Removal Fluids Contains amines. Do not add sodium nitrite or other nitrosating agents which may form cancer causing nitrosamines. Wash hands thoroughly after handling. Add material slowly when mixing with water. Do not add water to the material; instead, add the material to the water. Avoid contact with eyes, skin, and clothing.

Conditions for safe storage, including any incompatibilities:

Store in original tightly closed container. Avoid contact with oxidizing agents. Store away from incompatible materials.
